It is especially in the field of longitudinal research and analysis, including panel research, that progress has been made in recent years. Many comprehensive panel

data sets as, for example, on human development and voting behaviour have become available for analysis. The number of publications based on longitudinal data has increased immensely. Papers with causal claims based on cross-sectional data only experience rejection just for that reason.
